Recent changes in The Divorce Act mandate that you must try alternative dispute resolution to resolve conflict before you can be seen in front of a judge. This reflects how straightforward the laws are and how the system recognizes the wasted resources spent on fighting. The Provincial and Federal laws predetermine most outcomes. The only exception is if there are safety or other concerns that would make alternative dispute resolution inappropriate.

Canadian Divorce Law is a no-fault system. This means there doesn't need to be a "matrimonial offence," like adultery, to allow a divorce. It also means that your spouse's behaviour during your marriage, i.e. conflict, affairs, verbal abuse, is not relevant to the division of assets. There is no point sticking it to each other except to rack up costs and deplete your own net worth.

In Canada, you do not need a lawyer to get divorced.

Getting legal advice is smart before you sign off on your separation agreement. This can help ensure that your interests and legal rights have been protected and you understand exactly what you are signing. Using lawyers to help in this way makes good sense. In some provinces, independent legal advice is required to make a separation agreement binding.

Often, cases get stalled or derailed during the process of gathering financial information. Financial disorganization or lack of trust can wreak havoc. The process, however, is relatively straightforward regardless of investments, debt, or businesses. It does not have to be a daunting or scary task.

Going to trial may cost you in excess of \$100,000 and over three years of fighting. Most cases do not go to trial as people run out of money, time, and patience.

Perception is not fact, yet most matrimonial cases are fought based on attempting to turn perception into fact. Judges will make decisions based on perceptions presented by lawyers.

Here are the ways you can get a divorce in Canada

Online and Do It Yourself (DIY)

Pros: Cheap. Good for people who have no assets or dependent children. You may still need a separation agreement, and some online services will help you draft one.

Cons: You may miss important terms and protection, so this is only suitable for very simple cases. Many financial institutions will not accept a DIY separation agreement.

Med/Arb (Mediation/Arbitration)

Pros: When you hire the mediator, you also sign an agreement so that the mediator can make the final decision (act like the judge) if the parties cannot agree. This means there will be a guaranteed decision made whether you agree or not.

Cons: Most Med/Arb contracts result in arbitration, partly because it is easier for the mediator to just make a decision as opposed to moving two people forward and working through all the issues. You are giving the power of a judge to someone who is not a judge. Most people in a Med/Arb hold back information because they do not want it to be used against them in the final decision, so it is really not mediation but rather just arbitration. This process can be as expensive as going to trial.

Mediation (rising in popularity)

Pros: Less expensive and less stress. A non-binding way for you and your spouse to make decisions around money and children with a professional, well-trained mediator. The final step is the drafting of a separation agreement and getting independent legal advice to ensure nothing important was missed or that the outcome was biased in any way.

Cons: You must ensure you're working with a qualified mediator who has a process and is focused on making decisions. Otherwise, you could spend a lot of money going around and around, never achieving a resolution. If mediation fails, then you will have to go another route. Usually, you are still ahead financially because of the groundwork that has been laid.

Hire a Lawyer From the Get-Go

Pros: When there is domestic violence, or one spouse is out of the country or just will not participate in any form of mediation, hiring a lawyer makes sense. Getting legal advice from an independent lawyer is smart before signing anything binding.

Cons: Expensive (on average \$30,000 per couple) and destructive to relationships and co-parenting. In the past, hiring a good lawyer was the difference between a good settlement and a bad settlement. That is no longer the case, as the Canadian laws are very clear. They are paid better the longer it takes to resolve your case. Lawyers file affidavits* to substantiate your position. These claims regarding money and parenting are in writing and filed publicly. There is no confidentiality.

*Affidavits are documents filed in the courts to prove you are right and your spouse is wrong.

Collaborative Law

Pros: You hire lawyers whose contract says that they cannot go to trial, so the lawyers are more committed to getting things done without going to court.

Cons: Often very expensive. The major downside is that if the parties cannot resolve the issues, you have to fire the collaborative lawyer and hire a completely different lawyer and start all over again. For this reason, this type of practice has lost popularity.

Do It Alone (spouse will not do mediation)

Pros: Saves money and time. You can work with a company that specializes in helping you navigate through divorce so that you can reduce the time and money spent with your lawyer. It also gives you a chance to step back and evaluate different outcomes and settlements without pressure and will all the relevant information to make smart decisions.

Cons: Your spouse is not participating, so that causes challenges and is not ideal but better than other options. You have no control over what your spouse does or does not do.
